#### The Royal Descent of Jane Austen from the Plantagenets through Elizabeth of Lancaster to her mother Cassandra Leigh

13<sup>th</sup> great-grandparents: Edward III (b. 1312 – d. 1377) = Philippa of Hainault (b. c1314 – d. 1369)

12. John of Gaunt, Duke of Lancaster, etc. (b. 1340 – d. 1399) = (1<sup>st</sup> wife) Blanche of Lancaster (b. 1345 – d. 1369)

11. Elizabeth of Lancaster (b. before 1364 – d. 1425) = John de Holand, Duke of Exeter; Earl of Huntingdon (b. after 1350 – d. 1400) [a great-grandson of Edward I]

10. Constance de Holand (b. c1387 – d. 1437) = Sir John Grey of Ruthyn, KG (b. after 1378 – d. 1439)

9. Edmund Grey, 1<sup>st</sup> Earl of Kent (b. 1416 – d. 1490) = Katherine Percy (b. 1423) [from Chart 2 and Chart 6]

8. Anne Grey = John Grey, 8<sup>th</sup> Lord Grey of Wilton (d. 1499)

7. Edmund Grey, 9<sup>th</sup> Lord Grey of Wilton (b. before 1469 – d. 1511) = Florence Hastings (d. after 1511)

6. Elizabeth Grey (d. 1559) = John Brydges, 1<sup>st</sup> Lord Chandos of Sudeley (b. 1492 – d. 1557) [from Chart 4]

5. Hon. Charles Brydges of Wilton Castle (d. 1619) = Jane Carne

4. Sir Giles Brydges of Wilton Castle, 1st Baronet (b. c1572 – d. before 1637) = Mary Scudamore (b. 1600 – d. 1629) [who was descended from Owain Glyndwr, Prince of Wales, a.k.a. Owen Glendower]

3. Sir John Brydges of Wilton Castle, 2<sup>nd</sup> Baronet (b. 1623 – d. 1652) = Mary Pearle (b. c1618 – d. 1682)

2. James Brydges, 8<sup>th</sup> Lord Chandos of Sudely (b. 1642 – d. 1714) = Elizabeth Barnard (b. 1643 – d. 1719)

1. Hon. Mary Brydges (b. 1666 – d. 1703) = Theophilus Leigh of Longborough, Gloucestershire (b. 1647 – d. 1725)

Jane's Grandparents: Rev. Thomas Leigh (b. 1696 – d. 1764) = Jane Walker (b. 1705 – d. 1768)

Jane's Parents: Cassandra Leigh (b. 1739 – d. 1827) = Rev. George Austen (b. 1731 – d. 1805)
